<u>Chapter – 6: statement of the categories of documents that are held</u> by EESL or under its control;

Every assignment or a task undertaken by EESL is initiated by officer(s) through a written noting, which run in a file to senior officer(s) for seek approval of the relevant/ applicable authority of EESL. All tasks to be carried out by EESL have to be explained in detail in such file noting and views or opinions of every officer involved in the approval process are also recorded in this same document. Further, all these records are retained as per the record retention rules of the Government of India. The public release of copy of these file noting is covered under the Right to Information Act, and if deemed permissible, can conveniently be sought from the designated Public Information Officer by filing an RTI application.

In addition to this, following are the of indicative categories of documents/ other records being held/ stored by various departments of EESL in their official capacity:

- 5. Custodian of such records: Supply Chain Management Department (or Contracts) Department

F) Documents pertaining to payment of relevant taxes, as applicable.

- 1. Invoices/bills.
- 2. Letter of Award and contractual agreements.
- 3. Memorandum of Understanding (MoU).
- 4. Test reports.
- 5. Supply and quantity records of commodities.
- 6. Verification reports.
- 7. Licenses and authorizations.
- 8. Work Orders and certificates
- 9. Documents of different services providers and vendors held under fiduciary relationship.
