This brazen display of money power did not go down well with the judges, who said: "You cannot buy justice with money." It went on to dismiss shah's special leave petition challenging the Gujarat High Court's February 17 decision, which had upheld an Ahmedabad trial court's Jury 13, 2015, judgment. The trial court had held Shah guilty of rash and negligent dirring, which caused the deaths of two students who were travelling in an autorickshaw. Both students were the only children of their parents.


