1. INTRODUCTION:

Energy Efficiency Services Limited (EESL) is a Joint Venture of NTPC Limited, Power Grid Corporation of India Limited (PGCIL), Power Finance Corporation Limited (PFC) and Rural Electrification Corporation Limited (REC), established to facilitate implementation of energy efficiency projects. EESL will work as ESCO, as Consultancy Organization for CDM, Energy Efficiency, etc.; as a Resource Centre for capacity building of SDAs, Utilities, financial institutions, etc. EESL will also lead the market-related actions of the NMEEE. It is first such company exclusively for implementation of energy efficiency in South Asia and amongst a very few such instances in the world.

2. <u>INDICATIVE PROJECT SCOPE OF WORK:</u>

2.1 About UP Gram Panchayat Project

- a) This is regarding the Government Order issued by Department of Panchayati Raj Government of Uttar Pradesh Ref no:1066/33-3-2021-38/2021 dated 02.07.2021 with Subject Gram Panchayat, Kshatriya Panchayat & Zila Panchayat receiving financial budget from Finance Commission for Supply & Installation of LED Street Lights, regarding supply & installation of LED Street Lights at different Gram Panchayats of Uttar Pradesh. In this order EESL has been authorized to supply LED Street Lights & perform other related works across all the districts of
 Uttar
 Pradesh.
- b) EESL intends to Supply, Transport, Install, & Commission LED Street Lights and required supporting Infrastructure Development Components (like arms & clamps, connecting wire, astronomical timers etc.) in various Gram Panchayats, Kshatriya Panchayats and Zila Panchayats across 75 districts of Uttar Pradesh. This project shall be done on PMC mode by EESL.
- c) For this activity, EESL is planning for installation of 10 lakh LED Street Lights in various Gram Panchayats, Kshatriya Panchayats and Zila Panchayats in Phase 1. Further EESL plans to hire "Demand Aggregator" who will, on behalf of EESL aggregate demand of LED Street Lights from various Gram Panchayats, Kshatriya Panchayats and Zila Panchayats across various districts in the entire state of Uttar Pradesh as per terms and condition of their work order.

2.2 Scope of Work for the Aggregator:

- Aggregator shall aggregate orders of LED Street Light on behalf of EESL from various Gram Panchayats, Kshatriya Panchayats and Zila Panchayats of Uttar Pradesh as mentioned in the list of Divisions and Districts mentioned in this document.


