The bidder is expected to examine all the instructions, forms, terms, specifications and other information in the bidding documents. Failure to furnish all information required by the bidding documents or submission of a bid not substantially responsive to the bidding documents in every respect will be at the bidder's risk and may result in rejection of bid.

#### 1.1.1 Source of Funds:

The Employer named in the BDS intends to use domestic funding for this Project. All eligible payments under the contract for the Tender for which this Invitation for Bids is issued shall be made by the Employer named in the BDS.

### 1.1.2 Eligible Bidders:

(i) This Invitation for Bids, issued by the Employer is open to all firms including company(ies), Government owned Enterprises registered and incorporated in India as per Companies Act, 1956, barring Government Department as well as foreign bidders/MNCs not registered and incorporated in India and those bidders with whom business is banned by the Employer.

A Bidder shall not have a conflict of interest. All Bidders found to have a conflict of interest shall be disqualified. A Bidder may be considered to have a conflict of interest with one or more parties in this bidding process, if:

- (a) they have a controlling partner in common; or
- (b) they receive or have received any direct or indirect subsidy from any of them; or
- (c) they have the same legal representative for purposes of this bid; or
- (d) they have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the bid of another Bidder, or influence the decisions of the Employer regarding this bidding process; or
- (e) a Bidder submits more than one bid in this bidding process, either individually [including bid submitted as an agent/authorized representative on behalf of one or more manufacturer(s) or through Licensee Licensor route, wherever permitted as per the provision of Qualification Requirement for the Bidders in Part B, Section-4] or as a partner in a joint venture, except for alternative offers permitted under the RfP Documents. This will result in the disqualification of all such bids. However, this does not limit the participation of a Bidder as a subcontractor in another bid, or of a firm as a subcontractor in more than one bid; or
- (f) a Bidder or any of its affiliates participated as a consultant in the preparation of the design or technical specifications of the Plant and Installation Services and Facilities that are the subject of the bid; or
- (g) a Bidder (including its personnel or sub-contractors) has a business or family relationship with a member of a EESL's staff (or of the project implementing staff, or of a recipient of a part of the loan) who: are directly or indirectly involved in the preparation of the bidding documents or specifications of the contract, and/or the bid evaluation process of such contract; or would be involved in the implementation or supervision of such contract unless the authority inviting tenders shall be informed of the fact/ such relationship at the time of submission of the tender and the conflict stemming from such relationship has been resolved in a manner acceptable to the EESL

#### 1.2 **Clarification on Bidding Documents**

A prospective Bidder requiring any clarification to the bidding documents may notify the EESL in writing or by post or by telex or telefax or email) at the EESL's mailing address indicated in the BDS. The EESL will respond in writing to any request for clarification or modification of the bidding documents that it receives no later than ten (10) days prior to the deadline for submission of bids prescribed by the EESL. Written copies of the EESL's response (including an explanation of the query but not identification of its source) will be sent to all prospective Bidders.

The Bidder is advised to visit and examine the site where the Facilities are to be installed and its surroundings and obtain for itself on its own responsibility all information that may be necessary for preparing the bid and entering into a contract for supply and installation of the Facilities. The costs of visiting the site shall be borne by the bidder fully.

EESL will also facilitate the bidder and any of its personnel or agents for getting permission from the authorities, where actual work is to be executed, to enter upon its premises and lands for the purpose of such inspection, but only upon the express condition that the Bidder, its personnel and agents will release and indemnify the EESL and also the authorities, where work is to be executed, and its personnel and agents from and against all liability in respect thereof and will be responsible for death or personal injury, loss of or damage to property and any other loss, damage, costs and expenses incurred as a result of the inspection.

Whenever the bidder is silent about the acceptance of RfP/IFB conditions such as bank guarantee, warranty period, liquidated damages, certification of relation clause no.1.1.2 [Conflict of Interest] etc. it shall be presumed that the bidder has accepted and certified RfP/IFB conditions and no further correspondence seeking specific confirmation about acceptance of these conditions shall be made.

### 2.4 Bid Security/Earnest Money Deposit (EMD)

Amount of Bid Security: Bid Security/Earnest Money deposit as mentioned in BDS is to be submitted.

The bidder shall furnish, as part of its bid, a bid security in a separate envelope (ITB sub clause 2.1). The bid security shall, at the bidder's option, in the form of a Banker's cheque, Demand Draft in favor of "Energy Efficiency Services Limited" payable at New Delhi or a bank guarantee as per format in Section 6. Bid security/EMD shall remain valid for a period of 45 days beyond the original bid validity period. If there is any extension in bid validity period, then EESL may ask the bidder to extend the validity of bid security.

If lead partner is mentioned in case of consortium, then bid security can be in the name of lead partner.

The bid securities of unsuccessful bidders will be returned as promptly as possible after the award is made to lowest evaluated bidder.

The bid security of the successful bidder will be returned when the bidder has signed the contract agreement, and has furnished the required performance security.

Please note that for Tender Conditions inter alia including exemption of tender fee, Bid Security etc. applicable for MSE and Start-ups, please refer **Annexure-II**:

The bid security may be forfeited if:

- a) If the bidder withdraws its bid during the period of bid validity as specified in the bid / RFP document. (Banning policy as per Annexure-IV of RfP document)
- b) If the bidder does not accept computational/arithmetical error correction made by EESL and as explained in "Financial Evaluation" section of the Bid/ RfP document.
- c) If the bidder does not accept assumptions, estimations etc. used for evaluation of bids as specified by EESL in tender documents and revision of his bid accordingly, in case other assumptions are used. If the bidder does not accept the sharing as specified in the bid.
- d) If the Bidder refuses to withdraw, without any cost to the EESL, any deviation not listed in Attachment 5 but found elsewhere in the bid; or
- e) In the case of successful bidder, if the bidder fails within the specified time limit:
- To sign the contract agreement within 28 days of placement of LoI/Award letter.
- To furnish the required performance security, in accordance with the tender document.
- 2.5 Power of Attorney as Attachment 3 of Section-6 in first envelope: A power of attorney duly authorized by a notary public, indicating that the person(s) signing the bid has/have the authority to sign the bid and thus the bid is binding upon the bidder during the full period of its validity in accordance with ITB sub clause 2.10.
- 2.6 Certificate Regarding Acceptance of Important Terms & conditions Please refer Part-A of BDS.
- 2.7 Deviations, if any, from the terms and conditions of bidding documents or technical specifications shall be listed only in Attachment 5 of Section-6 to the bid. The Bidder shall also provide the additional price, if any, for withdrawal of the deviations. However, the attention of the bidders is drawn to the provisions of ITB sub clause 4.6 regarding the rejection of bids that are not substantially responsive to the requirements of the bidding documents.

Bidders may further note that except for the deviations listed in Attachment 5, the bid shall be deemed to comply with all the requirement in the bidding documents and the bidders shall be required to comply with all such requirements of bidding documents and technical specifications without any extra cost to the EESL irrespective of any mention to the contrary, anywhere else in the bid, failing which the bid security of the bidder may be forfeited.

At the time of award of contract, if so desired by the EESL, the bidder shall withdraw these deviations listed in Attachment-5 at the cost of withdrawal stated by him in his bid. In case the bidder does not withdraw the deviations proposed by him, if any, at the cost of withdrawal stated in the bid, his bid will be rejected and bid security forfeited.

### 2.8 Bid prices

Unless otherwise specified in the technical specifications, bidders shall quote for the entire facilities on a "single responsibility" basis such that the total bid price covers all the contractor's obligations mentioned in or to be reasonably inferred from the bidding documents in respect of the design, manufacture, including procurement and subcontracting (if any), delivery, construction, installation, survey cost, monitoring and verification cost and completion of the facilities including supply of mandatory spares or spares to be supplied during warranty (if any). This includes all requirements under the contractor's responsibilities for testing, pre -commissioning and commissioning of the facilities and, where so required by the bidding documents, the acquisition of all permits, approvals and licenses, etc.; the operation, maintenance and training services and such other items and services as may be specified in the bidding documents, all in accordance with the requirements of the General Conditions of Contract and Technical Specification.

Bidders are required to quote the price for the commercial, contractual and technical obligations outlined in the bidding documents. If a Bidder wishes to make a deviation to the provisions of the bidding documents, such deviations shall be listed in Attachment 5 of Section-6 of its bid. The bidder shall also provide the additional price, if any, for withdrawal of the deviations, pursuant to ITB sub clause 2.7.

Bidders shall give a breakdown of the prices in the manner and detail called for in the price schedules.

#### 2.9 Price Basis

Price quoted in the bid must be firm and shall remain firm during currency of the Contract. Hence prices in Letter of Award shall be firm and not subject to escalation till the execution of the complete order and its subsequent amendments accepted by the bidder even though the completion / execution of the order may take longer time than the delivery period specified and accepted in the Notification of Award.

Statutory variation in applicable GST shall only be on account of Employer in case bidder has shown the rates of present taxes in their bid and other prices quoted by the Bidder shall be fixed during the Bidder's performance of the Contract and not subject to variation on any account. Even in case prices asked in Bid price Schedule are quoted as inclusive of taxes, tax rates shall be shown separately. Bidders shall quote all prices in Indian Rupees only. Employer shall bear no responsibility on account of Taxes and Duties other than GST.

### 2.10 Period of Validity of Bid

Bids shall remain valid for a period of Six Months from opening of Bids. A bid valid for a shorter period may be rejected by the EESL as being non-responsive. In exceptional circumstances, the EESL may solicit the bidder's consent to an extension of the bid validity period. The request and response thereto shall be made in writing thro' letters/ e-mails. If the bidder accepts to prolong the period of validity, the bid security/EMD shall also be suitably extended. A bidder may refuse the request for Bid Validity Extension without forfeiting its bid security. A bidder granting the request will not be required nor permitted to modify its bid.

#### 2.11 Format and Signing of Bid

The original copy of the bid, consisting of the documents listed in ITB Sub-Clause 2.1 shall be typed or written in indelible ink and shall be signed by the bidder or a person or persons duly authorized to bind the bidder to the contract. The authorization shall be indicated by written power of attorney accompanying the bid and submitted as relevant attachment under Section-6 to the bid under ITB sub clause 2.1. All pages of the bid, except for un-amended printed literature, shall be initialed by the person or persons signing the bid.

Any interlineations, erasures or overwriting shall only be valid if they are initialed by the signatory to the bid.

### 2.12 Contents of the Bid/proposal

The Bidder or consortium of bidders is expected to examine all instructions, forms, terms & conditions and scope of work in the RfP documents. Failure to furnish all information required or submission of a bid not substantially responsive to the RfP/Bidding Document in every respect will be at the bidder's risk and may result in the rejection of the bid.

EESL and/or its officers, employees disclaim all liability from any loss or damage, whether foreseeable or not, suffered by any person acting on or refraining from acting because of any information including statements, information, forecasts, estimates or projections contained in this document or conduct ancillary to it whether or not the loss or damage arises in connection with any omission, negligence, default, lack of care or misrepresentation on the part of EESL and/or any of its officers, employees.

### 2.14 Authorized Signatory (Bidder or Consortium of bidders)

The bidder or consortium of bidders as used in the RfP document shall mean the one who has signed the bid document. The bidder or consortium of bidders should be the duly authorized representative of the bidder/consortium of bidders, for which a certificate of authority/power of attorney will be submitted along with the offer. This should clearly define the authority provided to the authorized representative. Complete offer, all certificates and documents (including reply to any clarifications sought and any subsequent correspondences) shall be furnished and signed on all pages by the authorized representative.

The power of attorney or authorization, or any other document consisting of adequate proof of the ability of the signatory to bind the bidder or consortium of bidders shall be annexed to the bid as Attachment 3 in Envelope 1. EESL may reject outright any proposal not supported by adequate proof of the signatory's authority.

#### 2.15 Consortium related conditions

The bidder shall have the option to submit the bid/proposal either alone or along with other partner companies. Prerequisites for bidder have been specified in qualifying requirement and other parts of the RfP document. The lead partner shall be the sole point of contact for all purposes of the Contract. The lead partner will have the prime responsibility for the execution of the scope of work. Any information/clarification submitted to the lead partner by EESL will mean that the same has been conveyed to all partners. However, the partner companies should not be involved in any major litigation that may have an impact of affecting or compromising the delivery of services as required under this contract. The bidder or any of the partner companies should not have been black-listed by any Central / State Government or Public Sector Undertakings. If at any stage of tendering process or during the currency of the contract, any suppression / falsification of such information is brought to the knowledge, EESL shall have the right to reject the proposal or terminate the contract, as the case may be, without any compensation to the tenderer & forfeiture of bid security/EMD/CPG. All partners of the consortium/joint venture shall be liable jointly and severally for the execution of the contract in accordance with the contract terms

### 2.16 Contact details of the Bidder or Consortium of bidders

Bidder or Consortium of bidders who wants to receive EESL's response to queries should give their contact details to EESL. The Bidder or Consortium of bidders should send their contact details in writing at the EESL's contact address.

### 2.17 Taxes, Levies and Duties

Bidders are required to quote their prices inclusive of all taxes and duties except applicable GST. The Input Tax Credit (ITC) available, if any, under the GST Law as per the relevant Government policies wherever applicable shall be taken into account by the Bidder while quoting bid price. EESL's liability shall be only for applicable GST. Bidder is to arrange on its own to deliver the material at site. No road permit shall be provided by EESL.

#### C.Submission of Bids

Bids shall be submitted as per clause ITB sub clause 2.1 above and in line with the provisions of Annexure-I to this RfP Documents.

3.1 The Bidder shall upload the soft copy part of the bid as per the provisions of the e-portal (refer ITB sub clause 2.1 above) and submit the hard copy of documentary evidence towards Document fee or documentary evidence in support of exemption of Document fee (as applicable), Bid Security or documentary evidence in support of exemption of Bid Security (as applicable).

The envelope in hard copy shall

- (a) be addressed to the Employer at the address given in this RfP Documents, and
- (b) bear the tender name, the Invitation for Bids title and number indicated in the BDS, and the statement "Do Not Open Before [date]," to be completed with the time and date specified.

All the envelopes shall also indicate the name and address of the Bidder. If the envelope is not sealed and marked as required, the Employer will assume no responsibility for the bid"s misplacement or premature opening.

#### 3.2 Deadline for Submission of Bids

Bids must be received at the address specified in the BDS but no later than the time and date stated in the BDS. In the event of the specified date for submission of bids being declared a holiday for the EESL, the bids will be received up to the appointed time on the next working day.

The EESL may, at its discretion, extend this deadline for submission of bids by amending the bidding documents in accordance with ITB sub clause 1.3, in which case all rights and obligations of EESL and bidders will thereafter be subject to the deadline as extended.

#### 3.3 Late Bids:

The bidder shall not be permitted to submit the soft copy part of the bid by any mode other than uploading on the portal within the specified deadline for submission of bids. The e-Procurement system would not allow any late submission of bids through the portal after due date & time as specified in ITB sub clause 3.2.

In case Hard copy part of the bid is received by the Employer after the deadline for submission of the same prescribed by the Employer in the ITB sub clause 3.2, but the bidder has uploaded the soft copy part of the bid, the bid will be considered as late bid. In such a case, the soft copy part of the first envelope bid uploaded on the portal shall be opened in line with the provisions of Bidding Documents. Such bids will be rejected during preliminary examination. However, in case of MSEs who are exempted from submission of Document fee and Bid security in line with Annexure-II, submission of hard copy part after the deadline for submission of the same prescribed by the Employer in the ITB sub clause 3.2, shall not lead to outright rejection of the bid., but the documents required to be submitted in the hard copy part shall be sought through clarifications as brought out at ITB sub clause 4.2

No bid may be withdrawn in the interval between the bid submission deadline and the expiration of the bid validity period specified in ITB sub clause 2.10. Withdrawal of a bid during this interval may result in the Bidder's forfeiture of its bid security, pursuant to ITB sub clause 2.4

#### (D) Bid Opening and Evaluation.

### 4.1 Bid Opening Process

The Employer will open the Envelope -1 (First Envelope) i.e., Techno – Commercial Part in public in the presence of bidders" designated representatives who choose to attend, at the time, date, and location stipulated in the ITB sub clause 3.2. The bidders" representatives who are present shall sign a register evidencing their attendance. Bidder who has submitted their bid may view on line tender opening on the portal from their end. In the event of the specified date for the submission of bids being declared a holiday for the Employer, the bids will be received upto the appointed time on the next working day.

The bidders' names, the presence of bid security, and any such other details as the Employer may consider appropriate, will be get declared through the Portal by the Employer. However, opening of bid, whether or not accompanied with the Tender fee and/or bid security, shall not be construed to imply its acceptability which shall be examined in detail pursuant to the provisions contained in the Section-2 & 3.

The Employer shall prepare minutes of the bid opening in the form of Bid Opening Statement, including the information disclosed to those present.

Bids not opened at bid opening shall not be considered further for evaluation, irrespective of the circumstances and shall be send to archive unopened

#### 4.2 Clarification on Bids

During bid evaluation, the EESL may, at its discretion, ask the bidder for a clarification of its bid as per the BDS. The request for clarification and the response shall be in writing, and no change in the price or substance of the bid shall be sought, offered or permitted. The address for communication will be same as ITB sub clause 1.2.

### 4.3 Preliminary Examination of Bids.

The Employer will examine the bids to determine whether they are complete, whether required sureties have been furnished, whether the documents have been properly signed, and whether the bids are generally in order.

In case of non-submission of bid in the portal (soft copy part of the bid) within the stipulated deadline, then even if the bidder has submitted the specific documents in hard copy part in original within the stipulated deadline pursuant to ITB

sub clause 3.2 its bid shall be considered as incomplete bid, which shall be summarily rejected. Similarly, in case of non-submission of Hard copy part of the bid, but the bidder has uploaded the soft copy part of the bid, the bid will be considered as incomplete bid. In such a case, the soft copy part of the first envelope bid uploaded on the portal shall be opened. Such bids will be rejected during preliminary examination. However, in case of MSEs who are exempted from submission of tender fee and Bid Security, non-submission of Hard copy part shall not lead to outright rejection of the bid

### 4.4 Arithmetical errors rectification process

Arithmetical errors will be rectified on the following basis. If there is a discrepancy between the unit price and the total price, which is obtained by multiplying the unit price and quantity, or between sub totals and the total price, the unit or subtotal price shall prevail, and the total price shall be corrected. If there is a discrepancy between words and figures, the amount in words will prevail. If the Bidder does not accept the correction of errors, its bid will be rejected and the bid security will be forfeited in accordance with ITB sub clause 2.4.

The EESL may waive any minor informality, nonconformity or irregularity in a bid that does not constitute a material deviation, whether or not identified by the bidder in Attachment 4 to its bid, and that does not prejudice or affect the relative ranking of any bidder as a result of the technical and commercial evaluation, pursuant to ITB sub clauses 4.7 and 4.8.

### 4.5 Preliminary Evaluation

conditions for Evaluation

Prior to the detailed evaluation, the EESL will determine whether each bid is of acceptable quality, is generally complete and is substantially responsive to the bidding documents. For purposes of this determination, a substantially responsive bid is one that conforms to all the terms, conditions and specifications of the bidding documents without material deviations, objections, conditionality's or reservations. A material deviation, objection, conditionality or reservation is one (i) that affects in any substantial way the scope, quality or performance of the contract; (ii) that limits in any substantial way, inconsistent with the bidding documents, the EESL's rights or the successful bidder's obligations under the contract; or (iii) whose rectification would unfairly affect the competitive position of other bidders who are presenting substantially responsive bids.

### 4.6 Acceptance of Important Condition

No deviation, whatsoever, is permitted by the EESL to the provisions relating to the following clauses (Important Conditions). Party is to submit the following as Attachment 4 of Section-6 in Envelope 1:

Bidders are required to furnish a certificate as per Attachment 4, indicating their compliance to the provisions of the above clauses.

At the time of award of contract, if so desired by the EESL the bidder shall withdraw the deviations listed in attachment 5 at the cost of withdrawal stated by him, in his bid. In case the bidder does not withdraw the deviations proposed by him

The EESL's determination of a bid's responsiveness is to be based on the contents of the bid itself without recourse to extrinsic evidence. If a bid is not substantially responsive, it will be rejected by the EESL, and may not subsequently be made responsive by the bidder by correction of the nonconformity.

#### 4.7 Technical Evaluation

The EESL will carry out a detailed evaluation of the bids previously determined to be substantially responsive in order to determine whether the technical aspects are in accordance with the requirements set forth in the bidding documents. In order to reach such a determination, the EESL will examine and compare the technical aspects of the bids on the basis of the information supplied by the bidders, taking into account the following factors:

- a) Overall completeness and compliance with the technical specifications and drawings; deviations from the technical specifications as identified in Attachment 5 to the bid; suitability of the facilities offered in relation to the environmental and climatic conditions prevailing at the site; and quality, function and operation of any process control concept included in the bid. The bid that does not meet minimum acceptable standards of completeness, consistency and detail will be rejected for non- responsiveness.
- b) Achievement of specified performance criteria by the facilities as per scope of work
- c) Type, quantity and long-term availability warranty spare parts and also mandatory and recommended spare parts and maintenance services
- d) Any other relevant factors, if any, listed in the tender document, or that the EESL deems necessary or prudent to take into consideration.

#### 4.8 Commercial Evaluation

The EESL's evaluation of a bid will take into account, in addition to the bid prices indicated in price schedules in section 4 along with the corrections pursuant to ITB sub clause 4.3, the following costs and factors that will be added to each bidder's bid price in the evaluation using pricing information available to the EESL, in the manner and to the extent indicated in ITB sub clause 4.9 and in the technical specifications:

- a) The cost of all quantifiable deviations and omissions from the contractual and commercial conditions and the technical specifications as identified in Attachment 5 to the Bid.
- b) Compliance with the time schedule called for and evidenced as needed in a milestone schedule provided in the bid.
- c) The functional guarantees of the facilities offered as per scope of work.
- d) The extra cost of work, services, facilities etc., required to be provided by the EESL of third parties.

### 4.9 Evaluations of Deviations:

Pursuant to ITB Sub-Clause 4.8, the following evaluation methods will be followed:

#### a) Technical and Commercial Deviations

The evaluation shall be based on the evaluated cost of fulfilling the contract in compliance with all commercial, contractual and technical obligations under this bidding document. In arriving at the evaluated cost, the price for withdrawal of deviations shown in Attachment 5 to the bid will be used if necessary. If such a price is not given in Attachment-5, the EESL will make its own assessment of the cost of such a deviation for the purpose of ensuring fair comparison of bids.

b) Time schedule (program of performance)

The plant and equipment covered by this bidding are required to be transported/ shipped and installed, and the facilities are to be completed within the period as mentioned below.

Completion of all facilities/work: As per year/months indicated in SCC.

The above date will be the effective date specified in the contract agreement. Bidders are required to base their prices on the time schedule or, where no time schedule is given, on the completion date(s) given above. No credit will be given for earlier completion.

The master network and the key milestone dates will be discussed with the successful bidder and agreed upon in preaward discussion before issuance of Letter of Award. Engineering drawing and data submission schedule shall also be discussed and finalized before the issuance of Letter of Award.

After the Letter of Award, the contractor shall plan the sequence of work manufacture, supply, installation to meet the above stated dates of successful completion of facilities and shall ensure all work, manufacture, shop testing, inspection and shipment of the equipment in accordance with the required sequence.

c) Functional Guarantees of the facilities (if Applicable)

Bidders shall state the functional guarantees (e.g., performance, efficiency, consumption) of the proposed facilities in response to the technical specifications. In case a minimum (or a maximum, as the case may be) level of functional guarantees is specified in the technical specifications for the bids to be considered responsive, bids offering plant and equipment with such functional guarantees less (or more) than the minimum (or maximum) specified shall be rejected.

d) Work, services, facilities etc., to be provided by the EESL

Where bids include the undertaking of work or the provision of services or facilities by the EESL in excess of the provisions allowed for in the bidding documents, the EESL shall assess the costs of such additional work, services and/or facilities during the duration of the contract. Such costs shall be added to the bid price for evaluation.

### 4.10 Opening of Second Envelope

The Second Envelope i.e., Price Part of only those Bidders shall be opened who are determined as having submitted substantially responsive bids and are ascertained to be qualified to satisfactorily perform the Contract. Such Bidders shall be intimated through portal only about the date and time for opening of Price Part i.e., Envelope-2 (Second Envelope) of the Bids by the Employer. A negative determination of the bids shall be notified by the Employer to such Bidders through portal only and the Second Envelope submitted by them shall be sent to archive unopened and the bid security shall be returned.

The Price Part containing any deviations and omissions from the contractual and commercial conditions and the Technical Specifications which have not been identified in the First Envelope are liable to be rejected

- (a) The Employer's evaluation of a bid will take into account, in addition to the bid prices indicated in online Price Schedule (Second Envelope), the following costs and factors that will be added to each Bidder's bid price in the evaluation using pricing information available to the Employer, in the manner and to the extent indicated herein and in the Technical Specifications:
- (b) the cost of all quantifiable deviations and omissions from the contractual and commercial conditions and the Technical Specifications as identified in the evaluation of First Envelope, and other deviations and omissions not so identified;
- (c) any other relevant factors listed in this RfP Documents.

Pursuant to aforesaid, the evaluation shall be based on the evaluated cost of fulfilling the contract in compliance with all commercial, contractual and technical obligations under this Bidding Documents. In arriving at the evaluated cost, towards deviations whether material or minor identified in the evaluation of First Envelope, the cost of withdrawal indicated by the bidder in Attachment-5 of the First Envelope will be used. If such a price is not given except for material deviation, the Employer will make its own assessment of the cost of such a deviation for the purpose of ensuring fair comparison of bids. In those cases, where the bidder has taken a material deviation but has not indicated the cost of withdrawal, the bid shall be treated as non-responsive and shall not be considered further

### 4.11 Contacting the Employer

Subject to GCC Clause 20, no Bidder shall contact the Employer on any matter relating to its bid, from the time of the opening of bids to the time the contract is awarded.

Information relating to the examination, evaluation and comparison of bids and recommendations for the award of contract shall not be disclosed to bidders or any other persons not officially concerned with such process until the award to the successful bidder has been announced. Any effort by a Bidder to influence the Employer in the Employer's bid evaluation, bid comparison or contract award decisions may result in rejection of the Bidder's bid.

### 5. Award of Contract

#### 5.1 Award criteria

Subject to ITB Clause 5.5, the EESL will award the contract to the successful Bidder whose bid has been determined to be substantially responsive and to be the lowest evaluated technically acceptable bid or bid offering highest return to EESL as the case may be as per RfP/Bidding documents, further provided that the Bidder is determined to be qualified to perform the contract satisfactorily

Except for the deviations listed in Attachment-5, the bidder would be required to comply with all the requirements of bidding documents without any extra cost to EESL failing which his bid security will be forfeited. Further, the EESL may

request the bidder to withdraw any or all of the deviations listed in Attachment – 5 to the winning bid, at the price shown for the deviation in Attachment 5 to the bid. In case the bidder does not withdraw the deviations proposed by him, if any, at the cost of withdrawal stated in the bid, his bid will be rejected and bid security forfeited.

The mode of contracting with the Successful Bidder will be as per stipulation briefly indicated below:

Single Contract shall be placed for following Price Components:

- a) For supply of plant and equipment;
- b) For providing all services i.e., inland transportation for delivery at site, inland transit insurance, unloading, storage, handling at site, installation (including civil. - c) Any other Services as specified in the Contract Documents.

### 5.2 EESL's right to accept any bid and to reject any or all bids

The EESL reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids at any time prior to award of contract, without thereby assigning any reason thereof and incurring any liability to the affected Bidder or bidders or any obligation to inform the affected Bidder or bidders of the grounds for the EESL's action.

#### 5.3 Notification of Award

Prior to the expiration of the period of bid validity, the EESL will notify the successful bidder in writing by issuing Notification of Award (NOA) either through telefax/ scanned e-mail or though registered/speed post/couriered letter, that its bid /offer has been accepted. The Notification of Award (NOA) will constitute the formation of the contract.

The bidder shall return duplicate copy of the NOA/contract and the other enclosed documents duly signed as a token of acknowledgement, within 07 days from the date of receipt of this order. Bidder is to make two original copies of Contract Agreement as per the format attached in the RfP Documents.

Upon the successful bidder's furnishing of the performance security pursuant to ITB Clause 5.6, the EESL will promptly notify each unsuccessful bidder and will discharge its bid security.

#### 5.4 Cancellation

EESL reserves the rights to cancel the order in the part or in full by giving one-week advance notice thereby if-

- The bidder fails to comply with any of the terms of the order.
- The bidder becomes bankrupt or goes in to liquidation.
- The bidder makes general assignment for the benefit of the creditors and any receiver is appointed for the property owned by the bidder.

#### 5.5 Modifications

This order constitutes an entire agreement between the parties hereto. Any modifications to this Order shall become binding only upon the same being confirmed in writing duly signed by both the parties.

5.5.1 Signing the Contract Agreement

At the same time as the EESL notifies the successful Bidder that its bid has been accepted, the EESL will send the bidder the contract agreement provided in the bidding documents, incorporating all agreements between the parties.

### **5.6 Contract Performance Security**

Within twenty-eight (28) days after receipt of the Notification of Award, the successful bidder shall furnish the performance security for ten percent (10%) of the contract price or as specified in RfP/Bidding Documents and in the form provided in the section "Forms and Procedures" of the bidding documents or in another form acceptable to the EESL.

In case Joint Deed(s) of Undertaking by the Contractor along with his associate(s)/collaborator(s) form part of the Contract, then, unconditional Bank Guarantee(s) from such associate(s)/collaborator(s) for amount(s) specified in Bid

Failure of the successful Bidder to comply with the requirements of ITB Clause 5.4 and/ or Clause 5.6 shall constitute sufficient grounds for the annulment of the award and forfeiture of the bid security, in which event the EESL may make the award to the next lowest evaluated bidder or call for new bids.

### 5.7 Corrupt or Fraudulent practices:

The EESL requires that bidders observe the highest standard of ethics during the procurement and execution of such contracts. In pursuance of this policy, the EESL: defines, for the purposes of this provision, the terms set forth below as follows:

- (i) "Corrupt practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution; and
- (ii) "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of the EESL, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the EESL of the benefits of free and open competition;
- (iii) will reject a proposal for award if it determines that the bidder recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question;
- (iv) will declare a firm ineligible, either indefinitely or for a stated period of time, to be awarded a contract if it at any time determines that the firm has engaged in corrupt or fraudulent practices in competing for, or in executing, a contract of the EESL (as per Annexure-IV of RfP Document)

### 5.8 Ineligibility for Future Tenders

Notwithstanding the provisions specified in ITB sub clause 2.4 and ITB sub clause 5.4 and 5.5, if a bidder after having been issued a Notification of Award, either does not sign the Contract Agreement pursuant to ITB sub clause 5.5 and/or does not submit an acceptable Contract Performance Security pursuant to ITB sub clause 5.6, such bidder may be considered ineligible for participating in future tenders of EESL for a period as may be decided by the EESL.

Successful bidder is to submit interchangeability certificate for its product supplied for replacement during warranty and maintenance period and even when it is purchased from open market. In case due to change in technology, the supplied product is not available during warranty/ maintenance period than the improved version of product can be used in warranty/ maintenance period with same or improved technical parameters or the combination thereof after written communication of Engineer in Charge at same cost& terms and conditions. Successful Bidder, on whom letter of award has been placed, has also to confirm that the prices of improved version of product is not lesser than the original product or its parts in comparison.

In case any clause/provision mentioned in the RfP/Bidding Documents is not applicable with respect to scope of work required to be completed by the Contractor/Supplier, such clause/provision shall become redundant.

Any false declaration regarding Local Content by the bidder shall be taken in line with provisions of the PPP-MII Order.

Further, entities of countries which have been identified by the Nodal Ministry/Department identified under PPP-MII order, as not allowing Indian companies to participate in their Government procurement for any item related to that Nodal Ministry shall not be allowed to participate in bidding for all items related to that Nodal Ministry/Department, except for the list of items published by the Ministry/Department permitting their participation. The term 'entity' of a country shall have the same meaning as under the FDI Policy of DPIIT as amended from time to time.

# SCOPE OF WORK, ELIGIBILITY CRITERIA & OTHER TERMS AND CONDITIONS

#### 1. INTRODUCTION

Energy Efficiency Services Limited (EESL) is a Joint Venture of Power Grid Corporation of India Limited (PGCIL), NTPC Limited, Power Finance Corporation Limited (PFC) and Rural Electrification Corporation Limited (REC) to facilitate implementation of energy efficiency projects. EESL will work as ESCO, as Consultancy Organization for CDM, Energy Efficiency, etc.; as a Resource Centre for capacity building of SDAs, Utilities, financial institutions, etc. EESL will also lead the market-related actions of the NMEEE. It is first such company exclusively for implementation of energy efficiency in South Asia and amongst a very few such instances in the world.

#### 2. OBJECTIVES

- To facilitate preparation of energy efficiency projects for Demand Side Measures including municipal functions, agriculture, public building, lighting etc.
- To implement schemes, programs and policies of central and state governments or its agencies.
- o Partner with private ESCOs and other companies to promote energy efficiency.
- o To provide consultancy services in the field of energy efficiency, CDM projects, and other related areas.
- o To identify and impart training to build the capacity of stakeholders.

#### 3. SCOPE OF WORK

The brief scope of work essentially consists of following: -

- a) Design, Manufacturing, Testing, and Supply, Transportation, Insurance, Loading and Unloading, Storage, Handling, Accounting (including reverse supply chain), Comprehensive onsite/on-project stores Warranty of LED streetlights for upto 7 years, other related works & documentation of LED Street Lights as per Tender Terms and Conditions.
- b) Servicing warranty redemptions as well as providing light spares like drivers and SPD and other components
- c) Selection of suitable SPD in line with the Technical Specifications and required due diligence of capability and coordination testing of the product with each wattage offered.

- e) Bidder has to supply the material at designated site/ULB as per the direction of EIC of the project. Unloading of material at project site is in scope of bidder
- f) Storage and Management of Inventory in each Lot as per requirements of EESL EIC/Project In-charge as well as providing daily inventory MIS at Plant and Stores.
- g) Six-Monthly Training/ Refresher course to Project Team, Contractor Staff or ULB technicians for carrying out on-site installation & repairs of LED Street Lights during comprehensive warranty period.
- h) As SLA (95% uptime & rectification within 48 Hours) is to be attained all the time, successful bidder shall maintain/replenish sufficient buffer stock (equal to 5%) of each type of Luminaries at respective site through-out the warranty period with no cost escalation for rectification of fault for speedy resolution of failed LED lights.
- i) Following is to be understood by bidder and accordingly accounted for:
  - The damaged lights shall be attributed for Liability to be borne by Supplier/ DIC/ R&M Agency/ ULB (or DISCOM)/ transit after supply, as per the nature of damage.
  - o Missing / Theft shall be recorded with FIRs with due claim with insurance.
- j) In case of shortfall/non-maintenance of the required minimum buffer stock quantity of LED streetlights/spares beyond 50% the of buffer stock and its replenishment beyond 10 days from the date of intimation from EESL, a notional penalty at the rate of Rs. 100000 per month. For the period less than one month, beyond 10 days, same shall be calculated proportionality on pro-rata basis for actual number of days and shall be charged by EESL subject to a maximum of 5% of the total contract value from the payments due to bidder from the date when replenishment was supposed to be done till the actual date of replenishment.
- k) Defective materials received during supply and defects observed during warranty period shall be replaced/repaired within 15 days from the date of intimation from EIC. A notional penalty at the of Rs. 100000 per month shall be charged by EESL subject to a maximum of 5% of the total contract value in case defectives are not replaced/repaired in stipulated time. For the period less than one month, beyond 15 days, penalty shall be calculated proportionality on pro-rata basis for actual number of days.
- Provide list of stores already available on PAN India basis for information of EESL.
- m) Successful Bidder has to establish field offices/stores in the state(s) (and/ or states in case of shift of supply locations) before commencement of supply at field with adequate manpower at appropriate levels to coordinate with all agencies concerned and monitor supply, storage, accounting and warranty redemption of lights as per the scope of work under the subject LOA during the entire period of contract.
- n) A Complaint Management System (web-based tool) to be established by the successful bidder for complaint lodging, monitoring, action, attending and closure of warranty redemption requests.
- o) **Design Parameter for LED Fixtures from 18-35W** to be considered as per Annexure-C (as per Technical Specifications).

#### A. Design, Manufacture, Test, Supply and Warranty of LED Street Lights:

i. Bidder has to design, manufacture, test, supply and provides upto 07years replacement warranty of LED Street Lights based on the quantity as per BOQ, where

bidder has to repair the luminaire and also manufacturer has to visit the DIC vendor warehouse for repairing of streetlight by replacing the spare parts at the site as well as replacement of old fixture with new fixture if the fixture is not repairable. The technical specifications of the LED Luminaires to be supplied shall comply with the requirements given under Chapter "Technical Specifications" which forms part of the subject Tender documents.

- ii. During maintenance phase the scope of bidder shall cover technical failure and physical damage due to technical failure. In case the damage is due to mishandling, the same can be ascertained through physical inspection jointly by EESL EIC/PMC, DIC Agency and Street light Vendor's authorized representative. Such cases of damage due to mishandling of DICM contractor shall be booked to the Contractor and not to the supplier
- iii. The following nature/conditions for damaged LED streetlights shall be attributed to supplier:
  - Damaged Housing of LED lights on receipt at site
  - Glass broken with evidence of internal fuse / burst
  - LED Lights not glowing due to non-functioning of SPD & Driver (LED PCB)
  - LED Lights Lens getting damaged due to overheating
  - LED Lights gradually losing their brightness resulting in illumination lower than specification.
  - LED Lights back panel getting deteriorated / damaged.
  - LED Lights / LED Flood Light get damaged due to ingress of dust & water (IP failure)
  - Physically damaged SPD & Drivers on receipt at site
  - Blast due to internal failure of SPD/Drivers/LEDs. (Power quality in the specified range)
  - Any other failure which is not covered above but established during joint physical inspection and accepted by supplier.
- iv. The Bidder shall supply the entire LED Luminaire and part components of the Luminaires including other related item to the district store/depot of selected "Implementation Contractor" of EESL for Project execution & maintenance. The receipt of delivered material at the district store/depot (to be intimated by the Implementation Contractor) shall serve as the proof of material supplied to the designated location. Each consignment of material(s) receipt by the Implementation Contractor, shall be duly certified by the representative of Project Management Consultancy (PMC)/EESL.
- v. **Insurance:** As per Clause No-17 of Standard Supply GCC of Rfp.
- vi. Transportation, storage, Demurrage/Wharfage, etc.: Bidder has to supply the material at designated site/ULB as per the direction of EIC of the project. Unloading of material at project site is in scope of bidder. Transport to such place of destination in India including insurance, as shall be specified in the Contract, shall be arranged by the Successful Bidder, and the related cost shall be included in the Contract Price.
- vii. The specifications of the LED luminaries shall be as given under the Chapter "Technical Specifications" of Tender documents.

# B. Warranty of LED Luminaires during Repair & Maintenance phase for the contract period of upto (07) SEVEN YEARS:

- For repair / rectification / replacement of defective components of the Luminaires or entire Luminaire to restore LED Luminaire to glowing condition, bidder to supply entire LED Luminaires including replacement for defective components of the Luminaires & all materials required for the same. This shall include tilt-able adapter for angle adjustment (0° - 90°) & 3mtr. Aluminium wiring/cable per luminaire for connections up to supply tap-off
- ii. Bidder shall make proper arrangements for stocking up sufficient materials at their store/depot location specific to ULB/PSU/DISCOMS etc. during the contract period for ensuring that the non-glowing/faulty LED Luminaires (excluding the period of non-availability of power supply) shall be brought to glowing condition within a period not exceeding 48 hours & also keeping minimum an uptime of 95% at any point of time throughout the contract period in close coordination with the Implementation/maintenance Contractor. Bidder to ensure that material supplied by them should not be a constraint in fulfilling these conditions, failing which the bidder shall be liable to be penalized on behalf of the Implementation/maintenance Contractor.

- iv. Liability to Supply the Luminaires/components in case of theft, natural calamities, over voltage etc. EESL shall pay to the bidder on establishment of facts beyond the control of the bidder in such events.

Bidder shall provide 5% of supplied lights in functional condition at the time of delivery otherwise value equal to 5% of lights will be retained from Payment for respective consignment and shall be released on confirmation of receipt of these lights. These lights shall be considered as buffer/spare lights and the same will be utilised during maintenance process. These 5% Lights shall not be counted towards payment to vendors from EESL and shall be considered free of cost (FoC).
- vi. In addition, 5% Drivers and 5% SPDs have to be supplied with consignment itself otherwise value equal to 5% of lights will be retained from Payment for respective consignment and shall be released on confirmation of receipt of these spares (Drivers and SPDs). The requisite spares as indicated above (5%) shall be maintained by the vendor as buffer stock throughout the project.
- vii. Bidder to also ensure, throughout contract period, adequate inventory of buffer stock of spares, (i.e. Drivers and SPDs) for speedy resolution of failed LED lights and prompt replacement at project site. In case of shortfall/non-maintenance of the required minimum buffer stock of spares beyond 50% the of buffer stock and its

replenishment beyond 10 days from the date of intimation from EESL, a notional penalty at the rate of Rs. 100000 per month. For the period less than one month, beyond 10 days, same shall be calculated proportionally on pro-rata basis for actual number of days and shall be charged by EESL subject to a maximum of 5% of the total contract value from the payments due to bidder from the date when replenishment was supposed to be done till the actual date of replenishment.

viii. Comprehensive warranty for a period of upto Seven (07) years.

During comprehensive warranty, Vendor shall seamlessly maintain spare stock (i.e. Drivers & SPDs) of each type of Luminaries at respective site (5% of the supplied quantity of lights at each location) through-out the warranty period with no cost escalation for rectification and speedy resolution of failed LED lights.

ix. If above conditions are not met by the bidder, EESL reserves the right to make applicable deductions from payments.

#### C. Technical experience:

- The bidder shall submit details of in-house facilities for manufacturing LED Street Lights which shall include in-house SMT, wave soldering setup, TEST facility for electrical, electronic and photometry {essentially C type Gonio-photometer, integrating sphere} for measurement of Luminous flux and Luminous Intensity distribution and other testing facilities.
- The Bidder MUST have internal testing facility for testing of all electrical, photometric, calorimetric, thermal, ingress protection & other safety tests. - The BOQ for the Lights to be replaced provided in the RfP/Document is indicative. BOQ as per RFP shall form the basis for evaluation of Price Bids and shall constitute LOA Quantity.
- EESL reserves the right for variation in BOQ upto +20% of individual wattages /items under the LoA.
- Cables / wires (PVC insulated, as per IS:694, ISI marked) for connection from Luminaire to Overhead conductor / Underground Power supply cable: Cable/wires (each for phase and Neutral) minimum 3 m per light for entire BOQ is in the scope of supply of successful bidder and NO CHARGES ARE PAYABLE EXTRA. Cable coming out of housing the wire/cable rating and length & connectors to be used should be:
- For Wattages upto 110Watt: 3Core X 1.0 Sq. mm. Multistrand Aluminum Cable coming out of luminaire housing should be used with minimum of 3 meter length.
- For Wattages above 110Watt: 3Core X 2.5 Sq. mm. Multistrand Aluminum Cable coming out of luminaire housing should be used with minimum of 3 meter length.

- The outgoing Aluminum cable from the luminaire housing shall be connected directly to the supply/ phase jumper side using suitable wire glands crimped ferrules/thimbles/connectors as per the connection arrangement decided by the successful bidder.
- Supplies offered without the required wire length or rating or required SPD rating or tilting arrangement or without bi-metallic 3-wire terminal to accept the wire

- 6. Successful Bidder shall provide proper document of the items supplied/ repaired/ replaced on monthly basis such as Serial No., Batch No., Mfg. Date, and unique ID number.
- 7. Bidder must provide the invoice for the supplied items along with the unique ID number of each supplied items duly signed and stamped by the EIC.

#### E. Delivery Period and Supply schedule:

The material shall be allocated by EESL through valid PO's (Release Orders) indicating the supply location, quantity of LED streetlight and warranty period against each line item. EESL shall provide allocation of quantities to be supplied from time to time during the currency of contract with appropriate Dispatch instructions / Release Orders. Material shall be offered for PDI accordingly in line with the allocations provided.

- a) All the allocated quantity shall be dispatched within 30 days of the date of issuance of respective release order(s) / allocation intimation by EESL.
- b) All the allocated quantity (subject to upper limit of 50,000 numbers per instance irrespective of wattage) must be offered for PDI within 21 days from the date of EESL allocation/PO (release order) and must be dispatched within 2 days after receipt of MDCC. EESL shall arrange to depute its representative for PDI & provide Material Dispatch Clearance Certificate [MDCC] within 07 days of receipt of PDI call intimation from the vendor. If the allocated quantity exceeds 50,000 numbers per instance, then timeline for offer of PDI call shall get automatically extended proportionately on pro rata basis for LD purpose.
- c) EESL shall not give preferably more than one allocation (PO) per week.
- d) The supplier can improve upon the delivery schedule depending upon his capacity and production rate.

- e) Non-adherence of delivery schedule shall attract L.D as per contractual terms. Date of LR will be considered as date of delivery for LD purpose.
- f) In case of delay in offering of PDI by the vendor more than 21 days from the date of allocation, then the LD will be applicable from 22nd day to the date of receipt of PDI Call. Allocated quantity must be dispatched within 2 days after MDCC. Lorry Receipt (LR) date will be considered as date of delivery for LD purpose.
- g) Final clearance date [MDCC Date] will be considered as the executing date. If the executing date is after 28 days (21 days for PDI call+ 7 days for EESL inspection) of allocation date. Allocated quantity must be dispatched within 2 days after MDCC. LD will be applicable for the delay beyond 2 days after MDCC. Lorry Receipt (LR) date will be considered as date of delivery for LD purpose.
- h) Bidder must provide invoice copy along with the dispatch documents including copy of challan / LR, e-way bill, copy of MDCC, etc. for dispatched material to EESL EIC through email within one day of dispatch of material. This is a mandatory requirement for EESL records.
- i) In case of PDI failure during inspection, bidder has to bear the cost of PDI done after first failure.

Successful bidder should submit the detailed supply plan within 7 days from the issuance of LOA

- Receipt of raw-materials from the site-in-charge of vendor.
- Selection of SPD and Coordination Testing Plan
- Manufacturing timelines for various activities at works.
- Submission of Quality Plan.
- Submission of Type Test Reports
- Dispatch schedules [fortnightly commitments should be given]

Note: Bidder shall offer the lot for PDI minimum 7 days in advance to enable QA team to assign the officer for PDI well in advance for timely completion of PDI. The manufacturing date for lot offered should not be more than 2 months old.

Bidders must give sufficient evidence about their readiness to deliver on this commitment indicating availability of ready stock after testing and/ or scheduled dates by which the tendered quantity will be delivered including manufacturing date, testing completion date and material dispatch date. EESL shall ensure the release of LOI/ LOA/ Rate Contract expeditiously. Time Schedule includes the time required for manufacturing, testing, and rectifications if any, retesting, offer for PDI & its Clearance, dispatch of material and order completion in all respects to the satisfaction of the EESL.

The supply schedule committed by vendor during the initial phase should be complied by vendor and failing to which will lead to requisite penalty as per the powers of EIC.

In case on any non-compliance of the above, EESL reserves the right to purchase material from elsewhere at the sole risk and cost of defaulting vendor and recover all

such extra cost incurred by EESL in procuring the material including forfeiture of EMD/Bid Security/encashment of CPG or any other sources etc.

If any other unforeseen situation/s arise apart from those mentioned above, decision of EESL shall be binding on the Bidders.

#### F. Contract Validity:

Contract Validity for the awarded quantity shall be for a period of 1 year from the date of issuance of LOA / Rate Contract. Further, the same may be extended for period of another 3 months with mutual consent.

#### 4. TECHNICAL SPECIFICATIONS OF LED LUMINARIES

#### 4.a). LED Packages:

- i. Identical Ceramic Base High-Power single chip LED Packages, quoted below, are to be used in all lamps of any given wattage rating (Make, Order Code/Part Number, Operating current and LUMINOUS EFFICACY at OPERATING CURRENT). Any changes in parameters of LED Packages, w.r.t the details given by the bidder in the technical bids, will be treated as changes in design and such changes are allowed only with prior written concurrence of EESL. EESL reserves the right to accept the changes in design proposed by bidder post-award, if any, subject to Type Test for change in design as brought under Clause Quality Plan and Pre-Dispatch Inspection. Note- Multi Chip. array, multi die, mid power, integrated arrays and COB type chip are not permitted and supply offered with this type of chip will be rejected.
- ii. Operating current of LED (design): < 70 % of rated maximum forward current, limited to a minimum of 350 m A and maximum of 1000 mA.</li>
   Bidder to mention the details of Make and Order Code/Part Number of LEDs along with design operating current.
- iii. Wattage / Luminous efficacy rating:
  - 1. Wattage of LED Package- Design: One Watt Minimum to Five Watt Maximum
  - 2. Wattage at operating current: One Watt Minimum to Three Watt Maximum
  - 3. Luminous efficacy: >=150 Lumens/watt (at operating current (design) and Tj = 85 degC).

Bidder to specify number of LED Packages which will be provided in each Street Light wattage (to be mentioned for each Street Light rating) along with the wattage and luminous efficacy of LED at operating current & Tj=85 deg C.

- iv. Colour Rendering Index (CRI): >= 70
- v. Correlated Colour Temperature (CCT): 5000K& 5700KBin Only (ANSI).

  One bidder can use only LEDs from one Bin. Supplies from outside these ANSI Bins shall be rejected.

- vi. Estimated Life span of LEDs: > 50,000 hours (at operating current(design) Ref 1.b, Case Temperature of 105 deg C w.r.t Lumen maintenance of 70%, refer Clause 4 and 10.2 of IS:16103).
- vii. Limits of the harmonic current to be as per IS: 16102 (Part 2): 2012 and IEC 61000-3-2 with Total Harmonic Distortion < 10% for the complete fixture.
- viii. LED Chip shall compliance to IES: LM-8-/IS:16106 (Approved method for measuring lumen maintenance of LED light sources and LED lumen depreciation time to L70) Test report for same should be submitted.

Note: COB type LED chip is not acceptable.

#### 4.b). Street Light:

- i.Wattage rating: As per BOQ under Annexure-A
  Bidder to mention the design wattage of Street Lights offered.
- ii.Lumen output: As per BOQ under Annexure-A
  Bidder to mention the design Lumen output of Street Lights offered.
- iii.System Efficacy (lumen/watt): 120 lumen/watt (minimum) for less than or equal to 60W LED SL/FL and it should be minimum 130 Lumen/watt for more than 60W LED SL/FL.

Refer Annex-A for meeting the Minimum System Efficacy requirement considering the Maximum Wattage (Including BIS Tolerance) & Minimum Lumen Output (Including BIS Tolerance) for individual wattages wise fixtures.

iv.Operating voltage: 110 - 320V with cut-off protection and self-restart feature in case of-over/under-voltage and phase-to phase voltage (High-Low Cut). If high-low cut-off protection is not provided, the Driver should be with a constant light output for a operating range of 140 v - 270 V and should be able to withstand 110 V-320 V for 48 hrs and withstand 440 V for 48 hours- Light should be operational within 100 V - 300 V range.

#### v.Driver:

- The Driver must have thermal protection against 75 °C Ambient temperature with internal surge protection of minimum 6 KV. After 75 °C the SPD shall be working and it should fall back to safe mode. Compliance to EN 55015, EN 61547 (component levels only).
- O/p current ripple <5%
- Isolated Driver
- Thermal Protection limit TC + 15C, o/P current reduction by 15%
- The driver should be epoxy/ silicone/epoxy-silicone compound potted encapsulated within the light fixture that has separate optical & driver compartments. The fixture, with the encapsulated driver inside, must be IP-66 compliant. Asphalt based Potting compound is accepted but ONLY ASPHALT is not accepted. The potting material used should be flame resistant and be able to withstand operating field temperatures of above 100 deg C & the compound used should be silicone or technical equivalent in moisture- resistance and insulation resistant to prevent flash-over and leakage current. The compound should be designed such that it provides good thermal dissipation, Sound deadening, Moisture resistance, adhesion & electrical insulation.

- Bidder has to ensure to meet all Driver Reliability tests as per RfP. Bidder also to provide spare drivers quantity equal to 5% quantity of the supplied lights quantity with each supply. For CRS registration, copy of application or undertaking of having applied/intent to apply, to be submitted as proof, at the time of bid submission.
- Fully Potted (epoxy/silicone/epoxy-silicone compound or equivalent) encapsulated universal electronic driver Registered under the Compulsory Registration Scheme (CRS) (Complied with Sr. No-25: DC or AC supplied Electronic Control Gear for LED Modules (Applicable IS: IS 15885 (Part-2/Sec-13):2012. & IS 16104 for Performance).
- The Driver must have thermal protection against 75 °C ambient temperature with internal surge protection of minimum 6 KV.
- Luminaire along with driver should be IP-66 Compliant.
- vi. Serviceability of LED Luminaire: The driver should be replaceable at site if required. Bidder to provide necessary training to workmen of implementation agency, at the time of supplies and during the contract period.
- vii.LED Driver Efficiency: The efficiency shall be as follows: for wattage greater than 60W; Nominal efficiency should be minimum 90% and less than 60W efficiency should be Minimum 88%.
- viii. LED Streetlight Validation Test Plan: Bidder may submit internal test reports at the time of bid submission. Original NABL accredited third party laboratory test reports should be compulsory submitted before issuance of LoA for all the test requirement as per RfP.

ix. Frequency : 50Hz +/- 3%

x.Power factor :>0.95 xi.CRI of Luminaries :>=70

- xii. Housing: Pressure die cast aluminum alloy for guising (heat sink) for affective thermal management, sturdiness, excellence corrosion resistance, separate optical and control gear compartment and top opening for easy maintenance. i.e. The luminaries or designed in a way that there are two separate compartment one for optical assembly and another one for control gear compartment. Top maintainable control gear compartment ensure faster maintenance of drivers without compromising on optical compartment protection against water and dust (IP). Finishing of housing shall be polyester powder coated grey after phosphor chromate treatment.
- xiii.LED shall be mounted on heat sink conductive aluminum with fins to dissipate the heat to ambient air for affective thermal management.
- xiv.Length of LED Luminaire Cable: The length of the three core shielded supply cable for all types of LED luminaires must be minimum of 3 meters.

xv.Ambient Temperature : -10 to +50 Deg. C

xvi.Degree of protection (as per IS:10322): IP-66 across all wattages

(Original third party test report from NABL accredited lab/International Lab of equivalent accreditation supporting the same shall be furnished at the time of the bid submission). Necessary Guarantee &Warranty certificate must also to be submitted at the time of bid submission. (Only single housing fixtures allowed).

- xvii. Lens/Lens module for LEDs: LED Lights shall be provided with Lenses/Lens modules. Lens should be of material resistant to de-gradation during service, due to atmospheric components, to avoid adverse impact on light output. Lens shall be bolted (and not pasted However, bolted AND pasted/ snap-fit is acceptable) on to the MCPCB above the chips and the lens should be minimum IK07 impact resistant if it is also used as a lens cover. The type of Lenses suggested to be the following (Applicable for non-dimmable & dimmable LED luminaires). The minimum beam angle to be achieved for street-light applications is 135° along the road and 85° across the road:
  - 1. For 40 W LED street Light and lower Type 1
  - 2. For above 40 W LED streetlight and below 130 W LED street Light Type 1 OR 2
  - 3. For above 130 W LED streetlight and below 200 W LED street Light Type 3
  - 4. For High Bay and Flood Light application of 120 W to 160 W Type 4
  - 5. For High Bay and Flood Light application of above 160 W Type 5

All the above types as per IESNA for street lights.

The manufacturer is required to meet the uniformity requirements as per table given below under all circumstances.

- xviii. Cover Glass / Lens Cover: Glass Distortion free, clear, heat resistant, toughened, UV stabilized glass; Lens Cover Lens should be of material non-degradable during service, due to atmospheric components, to avoid adverse impact on light output.
  - xix. Cover Frame: Tempered protective custom molded polycarbonate diffuser, thermal shock and impact resistance (IK-08) fixed to the housing by means of SS309 stainless steel screws.
  - xx. Internal Voltage Surge protection: Relevant clause of internal surge protection in the tender may be referred.
  - xxi. Applicable Standard: IS:16107 read along with relevant IS Standards referred to within IS:16107.
- xxii. Life of the Street Light: Minimum 50,000 hours (Refer Clause 10 of IS:16107(Part2/Sec 1).
- xxiii. Luminaire Body Temp should not exceed 30 deg. C from ambient (45 deg. C) with tolerance of 10 deg C after 24 Hrs. (Original third party test report from NABL certified laboratory/International Lab of equivalent accreditation must be submitted at the time of the bid.)
- xxiv. Heat Dissipation/Heat Sink: INSITU/Thermal Test will cover this parameter. Manufacture must submit design/ drawing indicating maximum temperature point on

LED array. This value shall not exceed junction temperature of Tj - 85 deg C (Specified in LM 80 report at which life >50000 hrs.).

xxv. Manufacturer shall submit the Photo Biological Safety Test Report for the LEDs as per IEC 62471 and assessment of blue light asper IEC/TR 62778 — Ed. 1.0 at the time of the bid.

#### xxvi. Damage of Light Fittings due to Lightning voltage surges:

In case of voltage surges due to lightning, it is expected that lights, in the affected circuit, will fail in a group and not in an isolated manner. Hence, any such failure of lights in a group on account of Lightning surges, may be reported to the customer, along with circumstantial evidence preferably within 48 hours of such occurrence, for the purpose of damage claim. The responsibility for submission of supporting documentation rests with the successful bidder and the role of EESL shall be limited to facilitation of presentation of such claims by successful bidder to ULB/PSU/Discom.

#### xxvii. Protection from Voltage surges (SPD):

Bidders must provide appropriate surge protection arrangement, at each Street Light, to protect the Street Light from switching surges, which are expected/prevalent in Street Light supply networks in India. No claim for failure of Street Lights, on account of voltage surges other than Lightning surges, will be considered.

Additionally, as per ANSI C 136.2-2014/ UL-1449/ IEC 61643-11, External Surge protection (SPD) with Thermal Protection (TMOVs) or equivalent thermal protection of minimum 10 kA rating with capability to withstand a minimum of 25 pulses of each 20KV/10KA in all three modes L-N, N-E & L-E i.e total 75 pulses of 20 KV with 2 Ohms source impedance for the 10KA current to be separately installed (fixed with screws) within each fixture with IP protection for incoming and outgoing wires on SPD and Light. 2 Ohm source impedance for L-N, 12Ohm for L/N-E. Max Voltage protection level L-N = 1.5KV; L/N-E = 2.5KV. SPD should offer surge protection to both driver & IoT Nodes

Alternatively, Bidder may provide external SPD inside the driver compartment or special enclosed compartment adjoining the driver compartment or adjoining it with proper fixing (bolting / DIN rail arrangement) for SPD inside. The same shall be certified from independent lab and follow IEC 62305 & IEC 61643-11-2011. Successful Bidder is responsible for right selection of SPD and for providing the Test Certificate of the selected SPD from a NABL Certified Indian/ EPA Certified International Lab at the time of Bid. Successful Bidder is also responsible for getting coordination testing for selected SPD carried out and submit original reports signed by authorized signatory of the SPD manufacturer before start of supplies. The SPDs should be designed and so connected to the street light that in case the SPD fails, the power connection to street light is cut-off.

#### xxviii. Protection from Over Voltage:

The Street Lights should have constant light output for 120 V to 270 V range and shall be suitable for operation within the input supply voltage range of 100-300 V specified. Bidder is also responsible for providing all lights with over/under-voltage protection as well as cut-off and re-start feature in case of phase-to-phase voltage which protects

the light from high voltage (High-Low cut). If High-low cut is not provided, the light should have a constant light output for a operating range of 140 v - 270 V and should be able to withstand 110 V-320 V for 48 hrs and phase-to-phase voltage (440 V) for a period of minimum 48 hours. - Light should be operational within 100 V - 300 V range.

xxix. Fixing arrangement / Focusing of the Street Lights:

Bidders should make suitable provision/adaptors/adjustment in LED street lights housing suitable on bracket/pole top of existing Pole infrastructure during installation/replacement/ maintenance to ensure that major portion of light from Street Light is reasonably focused on to the center of the road and not outside the road. Charges for the tiltable adaptor shall be included in the quoted price. Any supplies without this adaptor shall be rejected.

- xxx. Tilt-able adapter for adjustment of boom angle  $(0^{\circ} 90^{\circ})$  which shall fit to any size of the arm. Supplies without tilt able adaptor, mounted on light housing, shall be rejected.
- xxxi. Pole entry/Retro Fitting: suitable for fixing in existing lighting pole with bracket and locking bolt & Nut.
- xxxii. Wiring Connections: Considering the frequent connection/wire joint failures, in case of Street Lights connected to Overhead Aluminum Conductors of supply network in the past from some of the locations in general and coastal areas in particular, special focus is required to be given in this regard to avoid high number of connection/joint failures which may lead to high number of non-glowing lights on this account and associated maintenance issues (delays and cost) which are avoidable.

Successful bidder shall obtain the details of existing wiring arrangement i.e., either use of aluminum wire from O/H conductor to Street Light or aluminum wire from O/H conductor jointed to copper wire from Street Light. Successful bidder is advised to decide, based on their experience, information and assessment on the connection arrangement, between LED Lights to overhead aluminum conductors of supply network, to be adopted. The probability of connection/joint failures in the place of each type of existing connection arrangement, considering the issues such as susceptibility of aluminum wire to snapping, possibility of corrosion failures of aluminum wires in coastal areas wherever applicable, reported problem with aluminum to copper joints, etc. may be considered before finalizing the connection arrangement. LED street lights shall be supplied pre-fitted with SPD from factory along with the suitable wire, glands, crimped ferrules/thimbles/connectors (for Copper-to-Copper connections) and bi-metallic connectors on supply/ phase jumperside as per the connection arrangement decided by the successful bidder. The sample connection arrangement, as specified above, need to be shown by vendors on actual lights to EESL at the time of pre-bid. Supplies offered without specified wire length, SPD, tilting arrangement and without bi-metallic 3-wire terminal to accept 3 sq mm wire, shall be rejected.

- xxxiii. The Luminaire casing shall carry EESL labels in EESL approved requisite sizing as to ensure clear visibility from the ground level below the light (i.e. from a vertical distance of 6-12 M).
- xxxiv. Each Street Light casing shall be provided with a unique serial number to be engraved or embossed on the enclosure of LED Street Light.
- xxxv. EESL reserves the right to ascertain conformance to IS:1944 w.r.t Illumination levels, where Road-Pole configuration is meeting NLC. Light Uniformity Ratio (Emin/Eavg) shall be as per IS 1944 based on category of road. EESL shall evaluate the performance of offered lights with the IES Files generated and those Bids with non-complying fixtures are liable to be rejected.
- xxxvi. The Street Light shall be built in such a way that it can withstand wind speed of 150 Kmph. NABL accredited lab report as per as per IEC/ES: 62262:2002 or International Lab of equivalent accreditation supporting the same shall be furnished by the manufacturer. (Impact resistance ≥ IK07).
- xxxvii. Variation in Driver output (Voltage & Current) at 110V and 320V w.r.t values at rated Voltage of 240V shall be within permissible limits as per IS: 16104(Cl: 7.2).
- xxxviii. All raw materials shall confirm to the National Lighting Code SP72: 2010.

Note: It mandates manufacturers of these products to get the product tested from BIS reorganized labs and subsequently apply for registration from BIS. Once the manufactures are registered with BIS under its registration scheme the manufacturer is permit to declare their articles confirm to the Indian Standards and put the standard mark notified by the Bureau.

EESL is also at liberty to inspect the Works of the bidder to assess Manufacturing Capacity, Quality Assurance Systems, input components and raw material quality along with finished product performance testing. Equivalent International Standards shall be applicable for International Bids in place of IS Standards as and where mentioned in the Bid document.
- 4. Cost of Sample Test to be borne by Bidder.

### 8. Price basis:

For guidance, it is clarified that charges for the following are considered as part of the prices quoted.

- a) Design, Manufacturing, Testing, Supply & transportation, transit Insurance, Loading and unloading Storage Handling Accounting (including reverse supply chain) of LED streetlights being retrofitted.
- b) The supplier is responsible for supply of new fixtures within stipulated time-frame
- c) Additional, buffer stock of Lights & Spares (SPDs & drivers).
- d) Cable/wire (Phase and neutral), minimum 3 meters per light, for connections.
- e) Tilt able adapter for adjustment of boom angle  $(0^{\circ} 90^{\circ})$ .
- f) Charges for all activities and supply of materials to be carried out under annual warranty for a period upto 7years from the date of completion of installations as certified by respective ULB/PSU/DISCOMs and EESL.
- g) Storage and handling is in scope of bidder till the supplies are handed over and accepted by EESL representatives. Once material is handed over to EESL with

# 9. <u>Guidelines to the Bidders - Walk through survey for analysis of existing infrastructure at ULBs while submitting bid:</u>

While submitting the bid, to select the right electrical, mechanical and photometry design of LED street light, it shall be the responsibility of the bidder to analyse the existing infrastructure as available at the project areas through visits to understand the existing electrical distribution network, streetlights installations, type of connections, special features of the existing network, type of poles, switching arrangements including local resources — contractors, availability of ladder mounted vehicles/hydraulic cranes, local ambient conditions which have impact on operation and maintenance of the LED Street Lights and their connection arrangements, etc. It is the responsibility of the bidder to acquaint themselves on the field conditions for offering the right LED light design, before submitting the bid.

### **10.EVALUATION CRITERIA**

- 1) The bids shall be separately evaluated as per RFP Terms & Conditions.
- 2) Price Bid's evaluation will be carried out based on the unit rate for each wattage of street light with 7 years warranty quoted by each bidder.
- 3) Every bidder must quote all the wattages/item as mentioned under-price table.
- 4) Price Bids shall be opened for all the wattages simultaneously.
- 5) The bidder with the lowest rate/price of each wattage/item shall be designated as the lowest bidder (L-1) for that respective wattage/item.
- 6) L1 (lowest price/rate) will be arrived from the total amount (Column H of price bid table at Annexure-III of Rfp) for each wattage of Street light supply with 7 years warranty.

- 7) The bidder needs to fill-up only one field (Column E of price bid table), i.e, unit rate for supply on FOR destination basis and rate for 7 years warranty (Column F) shall be automatically calculated in the price table as 35% of the unit price of LEDs quoted at Column E of price bid table (i.e. @ flat 5% per year for 7 years). Illustrative format & notes are enclosed at Annexure-III of Rfp.
- 8) A maximum of four (4) firms (including L-1) of each wattage of streetlights supply are proposed to be engaged on parallel Rate Contract-basis, and the bifurcation of quantity among the L-1 and other bidders in the ascending order of their originally quoted price (i.e., L-2, L-3, L-4 bidders) shall be as follows:

- 11) In case, the firms issued with RC Orders are unable to deliver the quantities as required, or falter in performance of the contract, EESL reserves the right to terminate the contract and approach other firms at the risk and cost of the defaulting supplier. Further, this right is without prejudice to the other available rights of EESL under the law.
- 12) It will, however, be the sole discretion of EESL to award the quantity irrespective of the band provided above, depending upon various factors, including the bidder's capacity, as assessed by EESL. In case, RCs are required to be placed on MSEs as per Public Procurement Policy for Micro and Small Enterprises (MSEs), provisions as mentioned at Annexure- II of Rfp shall be followed.
- 13) Please note that tender conditions applicable for MSEs and start-ups are mentioned at Annexure-II of Rfp.

### 11.Payment Terms

1. On Supply: Payment @ 100% of Part E (i.e., Supply cost) of price bid table enclosed at Annexure-III of RfP with 100% of GST within 60 days of receipt of the supplier's tax invoice at EESL office with receipt acknowledgement, signed and stamped by authorized representative at designated stores location along with submission of Material Receipt Acceptance Voucher (MRAV).

The payment shall be processed upon receipt of following:

- a. Acknowledgement of LOA/NOA and signing of Contract Agreement.
- b. Submission of Project Implementation plan duly accepted by Engineer-in-Charge (EIC), EESL.
- c. The supplier shall provide Contract Performance Guarantee (CPG) equivalent to 10% of total contract value to EESL within twenty-eight (28) days of receipt of the LOA.

- d. Submission of Product Clearance Report as per tender conditions duly certified by representative of EESL.
- e. Submission of material dispatch clearance certificate (MDCC) as per tender conditions duly certified by representative of EESL, if required.
- f. Submission of verified Proof of Delivery/MRAV.
- g. Submission of original supply Invoices/Bills duly verified/certified by EESL representative along with proof of delivery.
- h. If the invoice is incomplete, i.e., without complete set of documents then payment due date will start from the date of submission of all necessary documents.
- i. Successful Bidder shall provide 5% of supplied/invoiced lights which are found in functional condition at the time of delivery along with 5% Drivers and 5% SPDs shall be considered as buffer/spares, which will be utilized during maintenance process. These 5% lights, 5% Drivers and 5% SPDs shall not be counted towards payment to vendors from EESL and shall be considered as free of cost (FoC).

### 2. Conditions of Payment:

- a) The Agency must submit all the documents/reports as per the deliverables of this tender document. If work is not completed within the timelines as mentioned in the Scope of Work/ Deliverable or as provided by EESL, then respective payments will be done after deductions of the LD (Liquidated Damages) amount as per the relevant LD clause or other amounts as per terms & conditions.
- b) The payment shall be processed only upon receipt of (i) Acknowledgement of LoA/NOA and signing of contract agreement; (ii) submission of CPG as per tender documents in addition to deliverable documents.
- c) Agency will raise/submit GST Invoice as per prescribed format in GST law or as per the law for the time being in force, only after compliance of Payment Terms and its certification by EESL Officer in charge (OIC) or its authorized representative.
- d) The payment shall be inclusive of all charges except applicable GST, which shall be paid extra. Taxes should be indicated separately on the invoice.
- e) The amount will be payable in Indian Rupees as per payment milestones/ terms after successful completion of services rendered as per the deliverables mentioned in scope of work.
- f) No advance payment shall be made.
- g) Payment shall be released upon the passing of GST-ITC to EESL within prescribed timeframe in GST Law and after deduction of all applicable Taxes (Direct and indirect).

The payment will be made within 60 days from compliance of Payment Terms as mentioned above.

- ii). Submission of Monthly Satisfactory performance certificate from the authorized EESL representative of the respective State, stating that proper supplies of all type of spare items received on time to maintain the uptime and other performance compliances of ULB.
  - (a) For comprehensive on-site Warranty: Successful bidder shall ensure minimum 50% of buffer stock at any point of time verified by EIC in charge. In case of failure of LED streetlight which is brought to the notice of successful bidder (by mail, letter etc. by EIC). The same has to be rectified/changed within 48 hours of intimation. If vendor fails to correct the fault within 48 hours, the penalty starts with first penalty being levied on completion of 72 hours from logging of complaint. Penalty rate @ Rs. 100 per day per light shall be imposed by EESL subject to the maximum of 10% of total value of the contract from the payments due to the bidder from the time of completion of 72 hours from logging of complaint till the date of rectification.
  - (b) Ceiling limit of 10% of total contract value on all penalties cumulative shall be set, over and above the LD Limit of 5% for delay in Supplies and 5% for delay in

Submission of reports. EESL has the right to seek any additional documents / information / certification it deems fit prior to the release of any installment. Income tax shall be deducted as applicable under the rules. EESL is at liberty to carry out Third Party Inspection at any time during the contract period.

### Other terms and conditions related to payment terms:

- 1. At the time of payment of bills, the income tax, if any, shall be deducted at source as per Government rules and guidelines as may be prevailing at the time of payment. Further, for availing the benefit of lower income tax rates supplied from outside the Purchaser's country. Supplier shall provide Income Tax Clearance Certificate (ITCC)/ Tax Residency Certificate or any other relevant document/certificate as per prevailing law, from concerned tax authorities for claiming lower tax deduction, if any.
- 2. All the invoices shall be submitted to EESL for payment, once in a month only.
- 3. Vendor shall raise supply invoices state-wise once per month only.
- 4. For warranty invoices, vendor shall raise invoice for its 1st year warranty on prorata basis from the start of the warranty period for that particular supply at the end of that particular financial year and from second year onwards the same shall be raised cumulatively for entire year at the end of every financial year, statewise.
- 5. Payment will be made to the bidder within 60 Days after submission of Invoice complete in all respect i.e. with all the required documents and compliance of relevant terms & conditions of LOA duly accepted & certified by EIC, EESL. If the invoice is incomplete in any respect or if there is any non-compliance with relevant Terms & Conditions of LOA, counting of 60 days due date shall start from the date of submission of revised invoice/all necessary documents provided relevant terms & conditions of LOA have been fulfilled.

### 12. Warranty:

Supplier will provide comprehensive warranty up-to 7 years.

Supplier shall be fully responsible for the manufacturer's warranty in respect of quality and work man ship of the entire materials award by the Offer. Supplier must warrant all material against any manufacturing/technical defects during the warranty period.

During the warranty period supplier shall maintain the material and repair/replace all the defective components at the installed site at no additional charges whatsoever nature to the EESL.

Note: Warranty period will start after three (03) months from the date of receipts of material/LED SL at the concerned project site and same shall be certified by authorized representative of EESL/EIC.

### 13. <u>Liquidated Damages</u>

#### 13.1 for delay in Supply of Material:

a. In case of any delay in the execution of the SUPPLIES, beyond the stipulated time schedule, EESL reserves the right to recover from the bidder a sum equivalent to 0.5% of the value of the delayed supply/unexecuted portion of work for each week of delay

- and part thereof subject to a maximum of 5% of the total value of the contract. However, the LD will not be applicable for the period if delay is not on bidder's part.
- b. Alternatively, EESL reserves the right to purchase material from elsewhere at the sole risk and cost of the successful bidder/contractor and recover all such extra cost incurred by EESL in procuring the material from resources available including EMD/Bid Security/encashment of Bank Guarantee or any other sources etc.
- c. EESL also reserves the right to cancel the order completely or partly without any prejudice to the exercise of the actions under Clauses 'a' and 'b' above.

### 13.2 for delay in submission of report:

In case of any delay in submission of test report, beyond the stipulated time schedule, EESL reserves the right to recover from the bidder a sum equivalent to 0.5% of the total value of contract for each week of delay and part thereof subject to a maximum of 5% of the total value of the contract.

## 15. Quality plan and Pre-dispatch Inspection (PDI):

### a. Quality Plan:

Bidders shall submit typical Quality Assurance and Inspection Plan, including the details of in-process testing and Pre-Dispatch Inspection, along with technical bid. The Pre-dispatch Inspection Plan and Type Tests proposed to be carried out shall comply with the requirements under IS: 16107 (Part 2/Sec 1) and the other test requirements covered under IS: 16107 read along with other IS Standards referred to within IS: 16107. Type Tests and Acceptance Tests, as applicable under IS: 15885 (Part 2/ Sec 13) and IS: 16104 shall also be included.

- Pre-dispatch Inspection Plan shall be shared as per stipulated timeline mentioned in the tender.
- If PDI fails, then bidder shall offer next PDI call within 15 days after necessary corrective action. In case of 3 consecutive PDI failures, EESL reserves the right to invoke risk purchase clause and procure the required material at risk and cost of defaulting vendor.

### b. Type Tests:

EESL reserves the right to select two number samples for each of the wattages from Field/site, Manufacturing plant or from the lot offered and to send the same for Type Tests at an independent NABL Accredited Laboratory / International Lab of equivalent accreditation. EESL reserves the right to carry out Type Tests on Street Lights and the charges for the same shall be borne by the Bidder, until one successful instance of testing. (If LED Chip/Design is changed, during the course of execution, from the LOA Specifications then EESL reserves the right to carry out Type Test again until one successful instance of testing). EESL also shall periodically send random samples from field to NABL certified Lab / International Lab of equivalent accreditation for testing of all electrical and photometry parameters including lumen output, uniformity, beam angle, CRI, CCT etc., EESL shall also randomly check the quality of chips supplied from the original chip supplier/ testing lab, if required.

#### c. Pre-dispatch Inspection (PDI):

EESL reserves the right to carry out Pre-dispatch Inspection (as per enclosed format or an updated version of the same) at their works either on their own or through their authorized representative for any or all the lots of LED Street Lights/spares (SPD, Drivers, lights etc) to be supplied under subject LOA, as per Inspection Plan approved by EESL. All the requirements under this clause shall be applicable in case of each of the manufacturers from whom successful bidder may outsource the LED Lights.

Intimation for PDI should contain the details of Batch Number and Serial Number of Lights along with wattage of Lights offered for inspection. Each lot size should have atleast 20% of total BOQ quantities of lights; until and unless it exceeds the total remaining awarded quantity. All the Test Reports should contain Batch number as well as Serial Number. The Inspection call should be accompanied by a statement of the details of Make/Order Code/Part Number and Serial Numbers of LED Chips used in the Street

Lights offered for inspection (Street Light wattage-wise) along with the copies of documents in support of purchase/receipt of LED Chips (Invoice, etc.,).

PDI should include review of Internal Test Reports. Internal Test Reports should contain details of LED Chips used in the batch of Street Lights under inspection (Order Code/Part Number and Serial Numbers of LED Chips for each wattage rating of Street Lights). Internal Test Reports as well as PDI Test Reports shall be submitted for all Lights.

EESL reserves the right for collection of samples from Field, Manufacturing plant or from the lot offered for inspection at manufacturer's works for testing as per EESL Specifications/ IS: 16107 in a NABL Accredited Lab / International Lab of equivalent accreditation. EESL reserves the right to reject the entire lot offered or installed in case of Failure of the sample.

Variation in Driver output (Voltage & Current) at 140V and 270V w.r.t values at rated Voltage of 240V shall be within permissible limits as per IS: 16104(Cl: 7.2)

Type of sealing/marking of Street Lights cleared for dispatch – to be specified and the same are to be recorded during receipt inspection at site.

It is to mention that

- The Street Light casing shall carry EESL labels in EESL approved requisite sizing so as to ensure **clear visibility** of EESL logo from the ground below the installed light.
- Street Light casing must have a unique serial number engraved or embossed on the enclosure of SL on metal plate to ensure the warranty period.
- Following documents need to be provided by the supplier in respect with each light during dispatch along with invoice:
  - a). Unique serial number
  - b). wattage of street light
  - c). Manufacturing Month & Year
  - d). Invoice Number & date

*Note: Above points (a), (b) & (c) shall ensure during the PDI.* 

#### **16.Coordination with PMC:**

EESL may appoint separate agencies:

- 1. Implementation Partner: For Installation & Maintenance of LED Street Lights in area under jurisdiction of various ULBs/PSUs/Discoms for a contract period upto 7 years.
- 2. PMC/AMC: On behalf of EESL, for coordination & supervision of various activities, under Project installation and Annual Maintenance Contract periods, with ULB, executing agency and EESL.

Successful bidders shall provide all the relevant information and support to the said agencies for the scope of work covered under LOA placed on the successful bidder. Intimation will be given to the successful bidder by EIC in this regard after placement of LOA.

# 17. Project Management:

i. Bidder shall plan and is required to carry out activities simultaneously across various states to achieve the completion period and implementation schedule as specified under Clause 3 (E) above.

ii. Successful Bidder has to establish field offices in the – state(s) (and/ or states in case of shift of supply locations) before commencement of supply at field with adequate manpower at appropriate levels to coordinate with all agencies concerned and monitor supply, storage, accounting and warranty redemption of lights as per the scope of work under the subject LOA during the entire period of contract. This shall include fault/complaint management activities and site store management during repair and maintenance phase also. Penalties shall be applicable, as specified under Clause "Penalties and Liquidated damages", in case of non-deployment of site personnel for a period of more than 15 days during any calendar month.

### iii. Appointment of NODAL Officer by Successful Bidder:

For the purpose of this tender, successful bidder needs to provide/submit the Authorization letter (within 3 days from Date of LoA) with name, address, mobile no., email addresses, designations of at least 3 Senior Nodal Officers (Regular Employees of their organization), nominated by their top management (Director/ MD/ CEO), who are reachable through any means of communication and who shall be accountable to deliver the products and associated services to EESL as per the tender.

# iv. <u>Correspondence</u>: Post award, all correspondence by successful bidder shall be addressed to as brought out below:

- <u>Head-Contracts</u> for all issues pertaining to clarifications w.r.t contractual and commercial issues or requiring amendments on the terms and conditions of LOA in general.
- **Engineer-In-Charge (EIC)** all the activities pertaining to execution of the works at site, as per the provisions under the terms of the LOA, on behalf of EESL.
- **v. Warranty period** will start after three (03) month from the date of receipts of material/LED SL at the concerned project site and same shall be certified by authorized representative of EESL.
- vi. A Complaint Management System (web-based tool) to be utilized for complaint lodging, monitoring, action, attending and closure of warranty redemption requests. Bidder to provide login access to EESL project team for review of complaint handling process.
- **vii. Dedicated Official (Region-wise)** -Since the date of supply, every Bidder must have dedicated officials (region wise) to track the supply schedule along with resending the faulty lights back to factory works of vendor. The cost of transportation of lights will be borne by vendor.

### **18.** Compliance with all Statutory Regulations:

- a) Compliance of all the statutory requirements as may be required w.r.t the activities to be performed to execute the scope of work under the subject LOA including the requirements under Contract Labor Acts, safety of the workmen deployed, etc., shall be the responsibility of the successful bidder including all the expenditure incurred for the same. This includes all the requirements w.r.t the workmen under Sub-contractor(s) also. The successful bidder shall submit the documentation to EESL, on monthly basis, as required under the applicable statutory requirements.
- b) Successful bidder shall indemnify EESL for any accident, injury met by its labor, employee or any other person working for him. Any compensation sought by its

labour, employee or any other person working for him shall be paid by successful bidder as per settlement solely. EESL has no role to play in this matter.

## 19. Submission of Reports:

Following Reports shall be submitted by the successful bidder, as per the instructions of EIC:

- a. **Supply plan** to the respective state head need to be provided within 3days from the date of issuance of PO.
- b. **Soft copy** of PDI reports with MDCC for the respective states shall be submitted to the state head within 2days from the date of dispatch.
- c. **During the receipt of material at site** the documents need to be submitted viz. Invoice, e-way bill, LR copy, PDI/MDCC, Unique Id details etc.
- d. **Proof of receipt of material at site** Successful Bidder shall submit the material supply acceptance duly signed and stamp from authorized site engineer/representative of EESL.
- e. **Monthly Progress Reports for Repair & replacement of faulty light-** with details of Lights, Driver, SPD, LED Cable or any other items repaired/ replaced against the faulty lights. The report must specify the item wise % of failure rate. This report need to be submitted duly signed & sealed by EESL EIC & Supplier until the warranty period.
- f. **Monthly state-wise invoice report-** with details like invoice number, date of invoice, description of material, supplied qty, invoice value (excluding Tax), with payment released & pending details w.r.t payment milestone against the supply of material shall be submitted to the EIC/State Head.
- g. **Spares Inventory Monthly report**—on Stock of Drivers, SPDs and any other spares required for prompt service. to be provided to the respective state representative/state head.
- h. Any other Reports as may be directed by EIC.

In accordance with the provisions of GCC Clause 21 (Terms of Payment), the Employer shall pay the Contractor in the following manner and at the following times, on the basis of the Price Breakdown given in the section on price schedules. Payments will be made in the currencies quoted by the Bidder unless otherwise agreed between the parties. The Contractor may make applications for payment in respect of part deliveries as work proceeds.

#### 1. TERMS OF PAYMENT

- i). Submission of Monthly report with details of Driver, SPD, LED Cable or any other items repaired/replaced against the faulty lights. The report must specify the item wise % of failure rate. This report shall be duly signed & sealed by EESL EIC & Supplier.
- ii). Submission of Monthly Satisfactory performance certificate from the authorized EESL representative of the respective State, stating that proper supplies of all type of spare items received on time to maintain the uptime and other performance compliances of ULB.
  - (a) For comprehensive on-site Warranty: Successful bidder shall ensure minimum 50% of buffer stock at any point of time verified by EIC in charge. In case of failure of LED streetlight which is brought to the notice of successful bidder (by mail, letter etc. by EIC). The same has to be rectified/changed within 48 hours of intimation. If vendor fails to correct the fault within 48 hours, the penalty starts with first penalty being levied on completion of 72 hours from logging of complaint. Penalty rate @ Rs. 100 per day per light shall be imposed by EESL subject to the maximum of 10% of total value of the contract from the payments due to the bidder from the time of completion of 72 hours from logging of complaint till the date of rectification.

- 1. At the time of payment of bills, the income tax, if any, shall be deducted at source as per Government rules and guidelines as may be prevailing at the time of payment. Further, for availing the benefit of lower income tax rates supplied from outside the Purchaser's country. Supplier shall provide Income Tax Clearance Certificate (ITCC)/ Tax Residency Certificate or any other relevant document/certificate as per prevailing law, from concerned tax authorities for claiming lower tax deduction, if any.
- 2. All the invoices shall be submitted to EESL for payment, once in a month only.
- 3. Vendor shall raise supply invoices state-wise once per month only.
- 4. For warranty invoices, vendor shall raise invoice for its 1st year warranty on pro-rata basis from the start of the warranty period for that particular supply at the end of that particular financial year and from second year onwards the same shall be raised cumulatively for entire year at the end of every financial year, statewise.
- 5. Payment will be made to the bidder within 60 Days after submission of Invoice complete in all respect i.e. with all the required documents and compliance of relevant terms & conditions of LOA duly accepted & certified by EIC, EESL.

# 4 Payment towards Taxes and Duties

Employer is liable for and shall pay only applicable GST on various components of prices. Suppliers are required to quote their prices inclusive of all taxes and duties except applicable GST. The Input Tax Credit (ITC) available, if any, under the GST Law as per the relevant Government policies wherever applicable shall be taken into account by the Implementing Partner while quoting bid price. EESL's liability shall be only for applicable GST.

No increase in Taxes and Duties (in case of change), which are payable as per the Contract, shall be allowed beyond the original delivery/ Installation dates unless specifically stated in the Time Extension Letter, if any, issued by the Employer. The Employer will, however, be entitled to any decrease in the Contract Price which may be caused due to lower payable Taxes and Duties amount in case of delivery of Goods/ Installation beyond the original delivery/ Installation dates. Therefore, in case of delivery of Goods/ Installation beyond the original delivery/ Installation dates, the liability of the Employer shall be limited to the lower of the payable Taxes and Duties amount which may work out either on schedule date or actual date of despatch of Goods/ Installation

Notwithstanding anything above or elsewhere in the contract, in event that input Tax credit of the GST charged by the supplier, is denied by the tax authorities to the employer for reasons associated with non-compliance/incorrect compliance by the supplier, the employer shall be entitled to recover such amount from the supplier by way of adjustment from any of the subsequent invoices submitted by the supplier to the employer. In addition to the amount of GST, the employer shall be entitled to recover interest and penalty, in case any interest/or penalty is imposed by the tax authorities on the employer for incorrect/wrong availing of input tax credit. The employer shall determine whether the denial of credit is linked to the non-compliance/indirect compliance of the supplier and the said determination shall be binding on the supplier.

Note: In any case, EESL shall not fund the subject project from its own resources.

Out of the 25% target of annual procurement from micro and small enterprises 4% & 3% shall be earmarked for procurement from micro and small enterprises owned by Scheduled Caste (SC) & Scheduled Tribe (ST) entrepreneurs & Women entrepreneurs respectively. In the event of failure of such MSEs to participate in the tender process or meet the tender requirements and L1 price 4% & 3% sub targets so earmarked shall be met from other MSEs.
