Subject: Banning of Business to M/s Chandra Electric Works (M/s Chandra) for a period of two years from the date of issuance of this letter from participation in Tendering process of EESL.

Dear Sir,

- 1. WHEREAS, M/s Energy Efficiency Services Limited (EESL), had issued Letter of Award on 27.11.2021 for "Installation & Commissioning of 10,203 Nos. of Smart Electricity Meters with GPRS based Communication Module for A&N Electricity Dept. in Andaman" (LoA No.: EESL/06/RFP-R-181909023(1484)/Inst & Comm/STE/LoA-2122042/3239dated: 27.11.2021)
- 2. AND WHEREAS, M/s Chandra has submitted the invoices for the work done against the aforesaid mentioned LoA. In invoice submitted by M/s Chandra, you claimed Rs. 46,02,000 as the transportation charges of Manpower from Mainland to Andaman.
- 3. AND WHEREAS, based on an investigation in consultation with the concerned Airlines, it was found that most of the tickets claimed by M/s Chandra are forged/ fabricated. This alleged act of submitting forged tickets has been purportedly committed by M/s Chandra to defraud EESL of amounts and monies that are not due to M/s Chandra.
- 4. AND WHEREAS, EESL, considering all the relevant aspects and as part of the due process and also following the principles of natural justice, has issued the Show Cause Notice to M/s Chandra on 04.01.2024 for seeking clarification as to why M/s Chandra should not be penalized, including blacklisting as deemed appropriate by EESL in line with relevant policy and guidelines of EESL and Government of India.
- AND WHEREAS, M/s Chandra has failed to reply to aforesaid Show Cause Notice within the given timeline of 30 days.
- 6. NOW THEREFORE taking cognizance of above and that no response have been received against the notice served to M/s Chandra, it is hereby informed that will out

Chandra Electric Works is hereby banned from participating in tendering process of EESL tenders for a period of 2 years w.e.f. 15.07.2024 and up to 14.07.2026 (i.e., the period of banning). Also, bids submitted by M/s Chandra shall be rejected in all such tenders in which the contract is yet to be awarded.
