1. WHEREAS, M/s. Energy Efficiency Services Limited (EESL), had Issued RfP/ Tender on 22.04.2024 for "Dismantling, Installation, Commissioning for 40,194 no's of LED Streetlights and Repair & Maintenance of 1,33,133 no's of LED Streetlights for a period of 05 years or till the project completion of respective ULB and other related works in 67 ULB's project in the state of Telangana". NIT No. EESL/ 06 /24-25 / SERC-SCM-Contracts/SLNP / 67ULBs / DIC / R&M / OTE-242501, dated 22nd April 2024.
2. AND WHEREAS, M/s. Vinci Global Private Limited has submitted their bid against the invitation of bids for the aforesaid tender for which First Envelop (Technical Bid) was opening on 14.05.2024 and price bid was opened on 13.08.2024.
3. AND WHEREAS, EESL, vide its e-mail communication dated 16.08.2024 had solicited consent from M/s. Vinci Global Private Limited in line with provision of the RfP documents, regarding Justification through BOM Form.
4. AND WHEREAS, M/s. Vinci Global Private Limited vide E-mail dated 23.08.2024 has withdrawn / modified its bid by mentioning that they choose to opt out this tender considering due to their financial situation and budgets.
5. AND WHEREAS, the reply to e-mail communication from the M/s. Vinci Global Private Limited, had been thoroughly examined and analyzed in EESL.
6. WHEREAS, provisions of L1 back out of aforementioned RfP Documents (ref I) as submitted by M/s. Vinci Global private Limited in its bid, stipulates that if the bid submitted by the bidder After opening of price bid, if L1 bidder backs out, the bidder will be put on holiday list of EESL for a period of one year. During this tenure, the bidder will be barred from participation in EESL tendering process from bid submission due date above referred tender.

NOW THEREFORE taking cognizance of above, it is hereby informed that without prejudice to any other rights available to EESL in terms of provisions of RfP documents and / or the applicable law, it has been decided that M/s Vinci Global Private Limited PRM Heights, First Floor, 1-89/A/25, Plot No: 13, Kavuri Hills, Hyderabad - 500081 is hereby suspended from participating in tendering process of EESL tenders for a period of 01(one) year w.e.f 14.10.2024 and up to 13.10.2025 (herein after to be referred to as Suspension Period) as per the following:

- a. Tenders for which price bid(s) is opened: The bid(s) of M/s. Vinci Global Private Limited is not considered responsive for Award of contract.
- b. Tender awarded to M/s. Vinci Global Private Limited during the Suspension Period : Tender(s) awarded to M/s Vinci Global private limited shall be cancelled without any implication to EESL.

For the sake of clarity, any contract or letter of award issued prior to the Suspension Period i.e. from 14.10.2024 to 13.10.2025 shall continue as per the terms and condition of the relevant RFP(s), if any; and tenders for which price bids is opened, shall not be considered responsive; including the tenders or letter of award issued inadvertently or otherwise during this Suspension Period i.e. from 14.10.2024 to 13.10.2025.
