Based on final testing and NIC's compliance policy following recommendations are suggested:

1. Site may be hosted with the permission of read and script execute for the general public.*
2. The complete website should be deployed over SSL using TLSv1.2 stable version. All weak SSL Cipher suites should be disabled.
3. Web server and OS Level hardening need to be in place for the production server.
4. All the software components used in the application should be of latest and stable version.
