- 1. WHEREAS, Energy Efficiency Services Limited (EESL) had issued Notification of Awards (NoAs) dated 24.02.2025 to M/s. Mankha Electrotech Pvt. Ltd. for "Refurbishment & Restoration for the revival of the solar plant with Operation and Maintenance for the remaining period up to 10 years of operation from the date of commissioning of the 48 sites of distributed solar plant of cumulative capacity 51.89 MWp in Maharashtra".
 - AND WHEREAS, M/s. Mankha Electrotech Pvt. Ltd. has failed to submit the required Contract Performance Guarantee (CPG) as per NoA terms and conditions despite several reminders cum notices, and follow-ups including meetings on dated: 08.04.2025 and 09.04.2025.

- 3. AND WHEREAS, EESL, after considering all the relevant factors and following the principles of natural justice, issued an intimation notice to M/s. Mankha Electrotech Pvt. Ltd on 22.04.2025 requested to confirm the date of submission of the CPG on or before 30.04.2025. Further, also informed that failure to comply shall be treated as a breach of contract, rendering your firm liable for appropriate action, including but not limited to termination of the contract and blacklisting, in terms of the contractual provisions (Clause No. 5.8 of ITB). Even after repeated reminders, M/s. Mankha Electrotech Pvt. Ltd has neither submitted the CPG nor informed the BG submission date.
- 4. AND WHEREAS, MANKHA has failed to perform and fulfilled its duties & responsibilities as per the subject contract and not doing any kind of refurbishment & restoration for the revival of the solar plant with Operation and Maintenance for the remaining period up to 10 years of operation from the date of commissioning of the 48 sites of distributed solar plant of cumulative capacity 51.89 MWp in Maharashtra at the mentioned sites and MANKHA has also stopped responding the Email & Letter of EESL.
- 5. AND WHEREAS, it may be mentioned that the subject project is of national interest involving public money. Because of MANKHA's default, there would be constraints of power / electricity to the local agriculturist and the whole objective of having such developmental project of government for the said strata of society will be defeated. Pursuant to the Notices of Defaults, Minutes of Meetings and other correspondences from time to time referred above, MANKHA's continued default in executing the subject contract and failure to fulfil its obligations, despite of EESL giving MANKHA ample opportunity to remedy the same and keeping the importance of project in view. This non-compliance, even in the face of multiple opportunities and reminders, has led to significant operational and reputational impacts for EESL, necessitating a decisive penal action against the firm.
- 6. NOW THEREFORE, in view of the above facts and circumstances, and the continued non-performance in performing Contractual obligations during project execution and towards submission of CPG by M/s. Mankha Electrotech Pvt. Ltd, it has been decided, without prejudice to any other rights available to EESL in terms of provisions of the contract, EESL Procurement Policy and/or the applicable law, that M/s. Mankha Electrotech Pvt. Ltd is hereby banned from participating in any tendering process of EESL for a period of two years with effect from 29.07.2025 to 29.07.2027. Any bids submitted by M/s. Mankha Electrotech Pvt. Ltd during this period shall be rejected, and the company shall not be eligible to participate in anytenders during this banning period.
- 7. This is issued without prejudice to EESL's rights to invoke remedies available to it under the Contract and also under the law.

This is being issued with the approval of the Competent Authority.
